## “CAREER READINESS AND EDUCATIONAL ADVANCEMENT THROUGH NATIVE YOUTH EMPOWERMENT” (CREATE BUDGET)

**WHEREAS,** The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

**WHEREAS,** Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

**WHEREAS,** The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and,

**WHEREAS,** The Tribal Council is responsible for oversight and review of all budget components; and,

**WHEREAS,** The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and,

**WHEREAS,** The Lumbee Tribe of North Carolina has received an award from the Department of Education in the amount of \$4,525,733.00; and,

**WHEREAS,** The grant will be administered in accordance with the award letter for a period of 5 years; and,

**THEREFORE,** Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “Career Readiness And Educational Advancement Through Native Youth Empowerment” (CREATE BUDGET) is amended for the Department of Education subject to all inclusions and provisions as described in the budget.





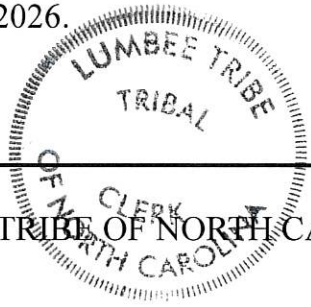
