WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribe of North Carolina is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina, and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina has an Education, Cultural and Public Relations Committee, and;

WHEREAS, The Education, Cultural and Public Relations Committee established the Lumbee Tribal Educational Scholarship to assist tribal members through scholarships in efforts to assist in the finances of their education, and;

WHEREAS, \$1000.00 was assigned for a creative writing and an art competition for grades 5-6, 7-8, and 9-12, and;

WHEREAS, Less students participated in the competitions than expected, allowing only \$500.00 to be used as the selected amount for major winners and participants, and;

WHEREAS, The remaining \$500.00 previously denoted for the creative writing and art competitions will be designated for a scholarship and shall be dispersed to the next ranking person as scored by the 2021 year scholarship committee, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby accept the responsibility of dispersing of a \$500.00 scholarships to the next ranking person as scored by the 2021 year scholarship committee.
