WHEREAS, The Lumbee Tribal Budget "BCBS/PEER SUPPORT GRANT" is addressed with the provisions as stated below; and

WHEREAS, The Lumbee Tribal Budget "BCBS/PEER SUPPORT GRANT" is to provide increased services and access to opioid use disorder treatment; and,

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as "BCBS/PEER SUPPORT GRANT", subject to all inclusions and provisions.
