WHEREAS, The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

WHEREAS, Tribal Council has the authority and fiduciary responsibility to ensure compliance with all programs funding and allocation; and,

WHEREAS, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and,

WHEREAS, The Lumbee Tribal Constitution compels the Lumbee Tribal Council to secure the health of the Lumbee people; and,

WHEREAS, The Lumbee Tribal Council acknowledges that water is life and as such, are compelled to protect water quality within the tribal territory; and,

WHEREAS, The UNC-CH Superfund Research Program, the UNC Institute for the Environment and Winyah Rivers Alliance have partnered for the purposes of enhancing the understanding hurricane-associated flooding on private well water to mitigate exposure to toxic metals; and,

WHEREAS, The aforementioned partners seek to explore collaborative opportunities with the Lumbee Tribe of NC (LTNC), while developing a plan to address any questions or concerns of the Lumbee Tribe IRB; and,

WHEREAS, This research will collect and analyze well water samples near, but not limited to, Maxton/Hayes Pond, and that all findings will be reported to the Lumbee Tribal Council and the LTNC; and,

THEREFORE BE IT RESOLVED, The Lumbee Tribal Council does hereby consent to collaborate with the UNC-CH Superfund Research Program, the UNC Institute for the Environment and Winyah Rivers Alliance, and support such research efforts; and,

BE IT FURTHER RESOLVED, This legislation shall be cited Resolution of Collaboration Between the Lumbee Tribe of NC, the UNC-CH Superfund Research Program, the UNC Institute for the Environment and Winyah Rivers Alliance.
