“DEPARTMENT OF JUSTICE/OFFICE ON VIOLENCE AGAINST WOMEN GRANT BUDGET”

WHEREAS, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

WHEREAS, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

WHEREAS, The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and

WHEREAS, The Tribal Council is responsible for oversight and review of all budget components; and

WHEREAS, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

WHEREAS, The Lumbee Tribe of North Carolina has received a grant from the US Department Justice in the amount of \$700,000; and

WHEREAS, The grant will be administered to identify, assess, and appropriately respond to child, youth, and adult victims of domestic violence, sexual assault, dating violence and stalking in rural communities by encouraging collaboration among victim service providers, law enforcement agencies, justice service providers, human and community service providers, educational institutions, and health care providers; and


THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “Department of Justice/Office on Violence Against Women Grant Budget” subject to all inclusions and provisions as described in the budget.



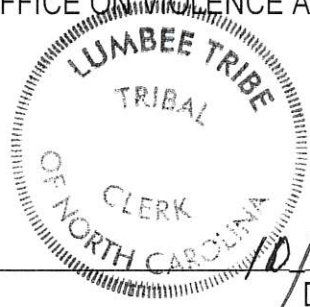
