WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, the Tribal Council per Article XI, Section 2 of the constitution has adopted CLLO-2005-008 amended to CLLO-2010-0312-01 cited as "Ethics and Conflicts of Interest", and;

WHEREAS, the Tribal Council per Article XI, Section 2 of the constitution has adopted Ordinance No. 2005-008 Amended CLLO-2010-0312-01 "Ethics and Conflicts of Interest", and;

WHEREAS, the Tribal Council per Article XI, Section 2 of the constitution has adopted Ordinance CLLO-2021-0617-02 "Establishment of the Lumbee Tribal Constitution Reform Committee", and;

WHEREAS, pursuant to Article X, Section 2 of the constitution the Tribal Council appointed Mrs. Louise Mitchell to the Lumbee Tribe Election Board on September 19,2019.

WHEREAS, the Tribal Council subsequently appointed Mrs. Mitchell to the Lumbee Tribal Constitution Reform Committee, and;

WHEREAS, the appointment of Mrs. Mitchell to the Lumbee Tribal Constitution Reform Committee by the Tribal Council is a violation of the duly enacted CLLO-2010-0312-01 "Ethics and Conflicts of Interest, and;

THEREFORE, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina hereby removes Mrs. Louise Mitchell from the Lumbee Tribal Constitution Reform Committee.
