THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as "FIRST NATIONS DEVELOPMENT GRANT & GOOD NEIGHBOR GRANT", subject to all inclusions and provisions.
