## "HEALTHY NATIVE NORTH CAROLINIANS GRANT BUDGET"

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget upon the Chairman's recommendation as deemed appropriate to maintain a balanced budget; and

**WHEREAS**, The Lumbee Tribe of North Carolina has received additional grant funds from the UNC American Indian Center for the "Healthy Native North Carolinians Grant Budget" in the amount of \$10,000 for operating year 2026; and

**WHEREAS**, The grant will be administered as described in the budget to follow; and


**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following amended ordinance cited as the "Healthy Native North Carolinians Grant Budget" shall be subject to all inclusions and provisions as stated by UNC American Indian Center.



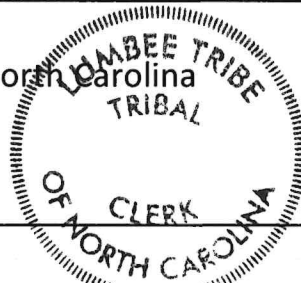
