#### "SUPPORT FOR THE PURCHASE OF ADDITIONAL COVID-19 TEST KITS"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent sovereign powers and right to self-government; and

**WHEREAS**, The Lumbee Constitution was adopted to preserve for all time the Lumbee way of life and community, promoting the educational, cultural, social, and economic well-being of Lumbee people, and securing justice and freedom for the Lumbee people; and

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"); and

**WHEREAS**, The Lumbee Tribe of North Carolina recognizes that COVID testing has declined we feel there is a false impression upon our community as it relates to COVID-19 and its existence, and

**WHEREAS**, The Lumbee Tribe of North Carolina is sensitive to the needs of its tribal members and wants to be a resource for the membership, and

**WHEREAS**, The Lumbee Tribe feels that additional testing is necessary to ensure the health and safety of its tribal members, and

**WHEREAS**, The Lumbee Tribe of North Carolina has played an integral part in the overall community response to COVID-19.

**THEREFORE, BE IT RESOLVED**, The Lumbee Tribe of North Carolina shall reimburse the Community Services Block Grant for the purchase of COVID-19 test kits from NAHASDA CARES Act Funds to provide outreach to the community.
