"ELECTION BOARD APPOINTMENT FOR DISTRICT 1: TRIBAL COUNCIL DISTRICTS 10, 11, 13, AND 19"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Chairman & Tribal Council to make nominations and confirm the nominees to the Election Board of the Lumbee Tribe of North Carolina, and;

WHEREAS, The Tribal Council created an ordinance defining "**ELECTION BOARD DISTRICTS.**"; and

WHEREAS, Daniel Locklear was nominated for District 1: (Tribal Council District 10, 11, 13 and 19) as board member to serve on the Election Board of the Lumbee Tribe of North Carolina, and;


THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the nomination and appointment of Daniel Locklear to the Tribal Elections Board to represent Tribal Council Districts 10, 11, 13, and 19. Daniel Locklear will serve a 6-year term, which will expire on April 17, 2031.
