WHEREAS, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt, and amend the annual fiscal year budget and budget process; and,

WHEREAS, The Tribal Council is responsible for overseeing, reviewing, and approving actual expenditures and budget variances throughout the fiscal year; and,

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget as proposed by the Chairman as deemed appropriate to maintain a balanced budget; and,

WHEREAS, The Boys and Girls Club of America receives donations and grant monies from various organizations throughout the year to be distributed to Boys and Girls Clubs across the country; and,

WHEREAS, The Lumbee Tribe of North Carolina does hereby project to receive \$30,000 from Boys and Girls Club of America for the fiscal year October 1, 2021 through September 30, 2022; and,

WHEREAS, The funding shall be administered and used for the Lumbee Tribe Boys And Girls Club as describe in the budget (see below); and,

THEREFORE, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the "BOYS AND GIRLS CLUB OF AMERICA BUDGET" subject to all inclusions and provisions.
