"PROPOSED AMEDEMMENT FOR GENERAL ORDINANCE ON CONTENT AND FORM OF ORDINANCES AND RESOLUTION"

SECTION 1: 7. THE CHAIRPERSON SHALL HAVE ~~THIRTY-TEN DAYS (30)~~ (10) FROM THE DATE AN ORDINANCE IS SUBMITTED TO SIGN IT, VETO IT, OTHERWISE, THE ORDINANCE IS CONSIDERED ~~VETOED~~ PASSED BY THE CHAIRPERSON.

SECTION 2: 1. EVERY RESOLUTION SHALL BEGIN WITH THE WORDS, "BE IT RESOLVED BY THE COUNCIL OF THE LUMBEE TRIBE OF NORTH CAROLINA." ALL RESOLUTIONS SHALL BE SIGNED BY THE CHAIRMAN SPEAKER AND ATTESTED TO BY THE TRIBAL COUNCIL SECRETARY.

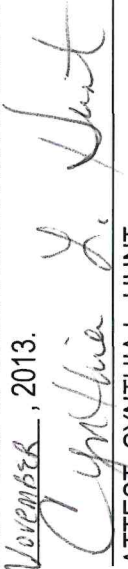
