### "CONTINUING RESOLUTION"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

**WHEREAS,** Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribal Council has budget oversight power, and:

**WHEREAS,** The fiscal year of operation of the Lumbee Tribe of North Carolina is October 1, 2021 thru September 30, 2022, and:

WHEREAS, The Annual Tribal Budget enacted by the Tribal Council will not be effective and binding until signed by the Tribal Speaker and posted for thirty (30) calendar days and;

**THEREFORE,** Be it Resolved, the Tribal Council of the Lumbee Tribe of North Carolina votes to approve this "Continuing Resolution" of the FY 2021-2022 Budget with the following provisions:

- 1. Effective October 1, 2022 all expenditures incurred will be attributed to the FY 2022-2023 budget when implemented.
- 2. This Resolution is effective October 1, 2022 thru November 30, 2022.
