WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina is required to make nominations to the North Carolina Commission of Indian Affairs, and;


WHEREAS, The Constitution Committee of the Tribal Council of the Lumbee Tribe of North Carolina has nominated Vernanda Oxendine, and;

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support and agree on the nomination of Vernanda Oxendine to the North Carolina Commission of Indian Affairs.


THEREFORE, Be it further resolved, Vernanda Oxendine will serve a 3 year term beginning July 1, 2022, representing NCCIA District 3: Tribal Council Districts 5,7, and 12 on the North Carolina Commission of Indian Affairs which will expire on June 30, 2025.
