WHEREAS, Our organization has received a letter of agreement from the Boys & Girls Clubs of America dated March 5, 2023 for grant number FOUR WINDS BOYS & GIRLS CLUB OJJDP 2022-51538, a federally funded grant in the amount of \$20,000 to be used for OJJDP 2022 Mentoring in Native American Clubs, and;
