WHEREAS, Our organization has received a letter of agreement from the Boys & Girls Clubs of America dated March 6, 2024 for grant number PEMBROKE BOYS AND GIRLS CLUB OJJDP 2023-52967, a federally funded grant in the amount of \$20,000 to be used for OJJDP 2023 Mentoring in Native American Clubs, and;
