## “NATIONAL FISH & WILDLIFE FOUNDATION/THE NATURE CONSERVANCY BUDGET”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I-b of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council has the authority to approve, enact and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for oversight and review of all budget components; and

**WHEREAS**, The Tribal Council has authority and fiduciary responsibility to ensure compliance with program funding and allocations; and

**WHEREAS**, The Lumbee Tribal Budget “National Fish & Wildlife Foundation/The Nature Conservancy Budget” will expand garden infrastructure at the Cultural Center, support land stewardship and forest farming planning, increase community food security, and provide seasonal agricultural labor support; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “National Fish & Wildlife Foundation/The Nature Conservancy Budget” subject to all inclusions and provisions.


