"COVID-19 PANDEMIC TRIBAL ENROLLMENT EXPIRATION RELIEF"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, the Lumbee Tribe Enrollment Office closed to the public on March 13, 2020 as a result of the COVID-19 pandemic, and;

WHEREAS, Public Health and Safety concerns related to COVID-19 have required the Lumbee Tribe Enrollment Office to remain closed to the public, and;


WHEREAS, Tribal Members have been unable to update their Tribal membership due to the office closure.

THEREFORE, Be it resolved that any Tribal Member who's tribal membership has previously expired after January 1, 2019 or will expire before November 11, 2020 is hereby extended until September 21, 2021, and,


THEREFORE, Be it further resolved that any Tribal Member who's tribal membership is extended through this resolution shall be deemed an active member and entitled to all rights and privileges of active tribal membership, including but not limited to voting in Tribal Elections.
