WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;


WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina annually adopts a fiscal year budget, which is inclusive of all tribal programs, and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina does accept Tribal Chairman Harvey Godwin, Jr's recommendation for Dr. Freda Porter for the position of Tribal Administrator and;


THEREFORE, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby agree to accept Dr. Freda Porter as Tribal Administrator through 1/10/2019, the end of the current Tribal Chairman's term and the contract as presented which will continue until 1/10/2019, the end of the current Tribal Chairman's term.
