WHEREAS, The Lumbee Tribal Council has the authority and responsibility to protect the quality of life of the Lumbee people; and

WHEREAS, The Lumbee Tribe of North Carolina has consistently supported improving the health of our tribal members; and

WHEREAS, The Lumbee Tribe Health Committee supports quality and affordable healthcare for our tribal members; and

WHEREAS, The Lumbee Tribe Health Committee encourages us to continue to promote a system of healthcare that is inclusive, affordable, accessible, and accountable and that members of the Lumbee Tribe of North Carolina advocate with their state appointed and elected officials for expanded access to health insurance.

BE IT THEREFORE RESOLVED, that the Lumbee Tribe of North Carolina fully supports the efforts of the Governor and Legislators of North Carolina to implement an expansion of Medicaid health insurance to cover the more than 500,000 of our fellow citizens and workers in this state and urges members of our community to call upon our legislative leaders and representatives to secure passage of the much needed legislation.
