## “CONSTITUTION REFORM COMMITTEE DISTRICT #4 MEMBER REMOVAL”

**WHEREAS**, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

**WHEREAS**, the Tribal Council per Article XI, Section 2 of the constitution has adopted CLLO-2005-008 amended to CLLO-2010-0312-01 cited as “Ethics and Conflicts of Interest”, and;

**WHEREAS**, the Tribal Council per Article XI, Section 2 of the constitution has adopted Ordinance No. 2005-008 Amended CLLO-2010-0312-01 “Ethics and Conflicts of Interest”, and;

**WHEREAS**, the Tribal Council per Article XI, Section 2 of the constitution has adopted Ordinance CLLO-2021-0617-02 “Establishment of the Lumbee Tribal Constitution Reform Committee”, and;

**WHEREAS**, pursuant to Article X, Section 2 of the constitution the Tribal Council appointed Dr. Christopher Clark to the Lumbee Tribe Election Board on August 20, 2020..

**WHEREAS**, the Tribal Council subsequently appointed Dr. Clark to the Lumbee Tribal Constitution Reform Committee, and;

**WHEREAS**, the appointment of Dr. Clark to the Lumbee Tribal Constitution Reform Committee by the Tribal Council is a violation of the duly enacted CLLO-2010-0312-01 “Ethics and Conflicts of Interest, and;

**THEREFORE**, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina hereby removes Dr. Christopher Clark from the Lumbee Tribal Constitution Reform Committee.
