“Resolution - Anti-War Russian Invasion on Ukraine”

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of The Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina has an Education, Cultural, and Public Relations Committee; and,

WHEREAS, Russian President, Vladimir Putin invaded Ukraine February 24, 2022; and,

WHEREAS, Vladimir Putin has used manipulative and destructive propaganda to inspire the Russia citizens and Russian allies to support his efforts to invade Ukraine; and,

WHEREAS, 4.7 million Ukraine refugees have fled from their homeland in fear of captivity, starvation, illness, torture, and death; and,

WHEREAS, Russian artillery and bombing have destroyed homes, hospitals, schools, bridges, roads, and entire communities, and have taken the lives of innocent victims and children in Ukraine; and,

WHEREAS, The physical and psychological effects of individuals as a result of war, tragically leaves traumatic distress and massive emotional scars; and,

WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina adamantly disapproves of the Russian invasion of Ukraine; and,

THEREFORE, Be it resolved, The Tribal Council of The Lumbee Tribe of North Carolina supports allied forces and all others who serve as supporters of Ukraine and its people, and who speak against and fight against evil and obstructive forces of innocent nations and victims.


