## "NORTH CAROLINA INDIAN HOUSING AUTHORITY"

**WHEREAS**, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;


**WHEREAS**, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Council of the Lumbee Tribe of North Carolina to confirm the nomination, and;

**THEREFORE, BE IT RESOLVED**, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the nomination of Mrs. SunSarae Harrell for appointment to the North Carolina Indian Housing Authority Board, and;

**THEREFORE, BE IT FURTHER RESOLVED**, Mrs. SunSarae Harrell shall be sworn in on June 18, 2026, at the Lumbee Tribal Council Business Meeting and shall serve a five-year term on the North Carolina Indian Housing Authority Board, subject to approval and appointment by the Governor of North Carolina, which term will expire on June 30, 2031.


