## “Healthy Native North Carolinians Budget”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and,

**WHEREAS**, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and,

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt, and amend the annual fiscal year budget and budget process; and,

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing, and approving actual expenditures and budget variances throughout the fiscal year; and,

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget as proposed by the Chairman as deemed appropriate to maintain a balanced budget; and,

**WHEREAS**, The Lumbee Tribe of North Carolina has received a grant from the UNIVERSITY OF NORTH CAROLINA at CHAPEL HILL to be named “Healthy Native North Carolinians Budget” in the amount of \$8,000.00; and,

**WHEREAS**, The grant shall be administered and used for the Lumbee Tribal Cultural Center as describe in the budget (see below); and,

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “**HEALTHY NATIVE NORTH CAROLINIANS BUDGET**” subject to all inclusions and provisions as stated by the University Of North Carolina at Chapel Hill.


