WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a federally recognized American Indian Tribe, governed by the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and vested with inherent powers of self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina is required to make nominations and appointments to represent the Lumbee Tribe of North Carolina on the North Carolina Commission of Indian Affairs, and;

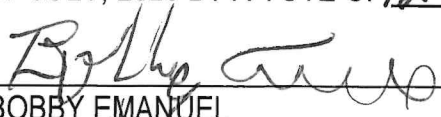
WHEREAS, The Constitution Committee of the Tribal Council of the Lumbee Tribe of North Carolina has nominated Aaron Butler for appointment to the North Carolina Commission of Indian Affairs, and;

NOW, THEREFORE, BE IT RESOLVED, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support and agree on the nomination and the appointment of Aaron Butler to the North Carolina Commission of Indian Affairs.

THEREFORE, BE IT FURTHER RESOLVED, Mr. Aaron Butler shall serve on the North Carolina Commission of Indian Affairs a 3-year term, representing Region 1: Tribal Council Districts 1, 2, 14, 16, 17, and 21, his term will expire on June 30, 2029.

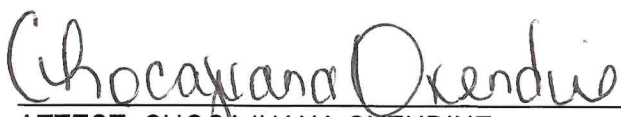
