WHEREAS, The Lumbee Tribal Budget "BCBS/COMMUNITY ENGAGEMENT GRANT" is addressed with the provisions as stated below; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as "CARES ACT BUDGET", subject to all inclusions and provisions.
