## “CULTURAL CENTER PROJECT (STATE) GRANT BUDGET”

**WHEREAS**, The Lumbee Tribe of North Carolina, a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section I of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina has the authority to approve, adopt and amend the annual fiscal budget and budget process; and

**WHEREAS**, The Tribal Council is responsible for overseeing, reviewing budget variances throughout the fiscal year; and

**WHEREAS**, The Tribal Council of the Lumbee Tribe of North Carolina reserves the right to amend the budget upon the Chairman’s recommendation as deemed appropriate to maintain a balanced budget; and

**WHEREAS**, The Lumbee Tribe of North Carolina is in receipt of a grant from the State of North Carolina in the amount of \$2,950,000; and

**WHEREAS**, The grant will be administered to carry out the Cultural Center Amphitheater Project; and

**THEREFORE**, Be it enacted by the Tribal Council of the Lumbee Tribe of North Carolina the following ordinance shall be cited as the “Cultural Center Project (State) Grant Budget” subject to all inclusions and provisions as stated by the grantor.



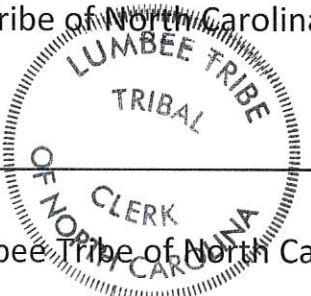
