LTNC Request for NCCIA Resolution of Support of CLLO-2020-0917-01 Tribal Consultation Mandate

**WHEREAS,** The Lumbee Tribe of North Carolina a recognized Tribe of the State of North Carolina Subject to the Constitution of the Lumbee Tribe of North Carolina and its inherent powers of self-government; and

**WHEREAS**, Article VII, Section 1 of the Constitution of the Lumbee Tribe of North Carolina delegates all legislative authority to the Tribal Council; and

**WHEREAS**, In 1971 the NC Commission of Indian Affairs (NCCIA) was created by the North Carolina General Assembly to advocate for local, regional, and national American Indian concerns, and;

WHEREAS, Despite the the positive relationship shared by the State of NC and the eight historic state recognized tribes: Coharie, Eastern Band of Cherokee, Haliwa Saponi, Lumbee, Meherrin, Occaneechi Band of Saponi, Sappony, and Waccamaw-Siouan, there exists a lack of true and meaningful government to government consultation when construction projects pose serious risks to the environmental and cultural resources of these tribal nations and mitigate their ability to secure their cultural heritage or provide safe, livable traditional lands for their members and residents, and;

**WHEREAS**, Federal regulations require government to government consultation with federally recognized Tribes, but these regulations neither require consultation with state recognized tribes nor cover Consultation between tribes and government, and;

**WHEREAS,** The US Advisory Council on Historic Preservation and the National Environmental Justice Advisory Council affirm that non-federally recognized tribes share the same types of concerns held by federally recognized tribes and may have important information to offer decision makers, and;

**WHEREAS**, All tribes in North Carolina will benefit from clear policy regarding government to government consultation at the state level, and;

WHEREAS, The Lumbee Tribal Council enacted CLLO-2020-0917-01 Tribal Consultation Mandate on September 17, 2020 which exerts Lumbee tribal sovereignty in demanding true and meaningful consultation in order to consider and mitigate the impacts upon Lumbee tribal communities, and;

**THEREFORE**, Be it resolved the Lumbee Tribal Council does hereby respectfully request the NCCIA to support the Lumbee Tribe of North Carolina Legislation CLLO-2020-0917-01 "Tribal Consultation Mandate Ordinance".
