“AMERICAN INDIAN VOCATIONAL REHABILITATION PROGRAM”

WHEREAS, The Lumbee Tribe of North Carolina (“Lumbee Tribe”) is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina (“Tribal Constitution”) and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina (“Tribal Council”), and;

WHEREAS, The Tribal Council Health and Human Services Committee was established to address the needs of Lumbee Tribal members, and provide recommendations to resolve health and human services issues tribal members, and;

WHEREAS, The Lumbee Tribe Vocational Rehabilitation Program is requesting the Lumbee Tribe of North Carolina to submit for funding for a fourth grant cycle.

THEREFORE, BE IT RESOLVED, The Tribal Council of the Lumbee Tribe of North Carolina does hereby agree to submit funding for the American Indian Rehabilitation program, and does hereby also agree to be the recipient of the American Indian Rehabilitation program grant if awarded.


