### "CONTINUING RESOLUTION"

**WHEREAS**, The Lumbee Tribe of North Carolina ("Lumbee Tribe"), is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers of self-government; and,

**WHEREAS,** Article VII Section 1 of the Tribal Constitution delegates legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, The Lumbee Tribal Council has budget oversight power, and;

**WHEREAS**, The Lumbee Tribal Council has the power to enact legislation to appropriate funds for operation of the tribal government, and;

**WHEREAS,** The fiscal year of operation of the Lumbee Tribe of North Carolina is October 1, thru September 30, and;

**WHEREAS,** The Annual Tribal Budget enacted by the Tribal Council will not be effective and binding until signed by the Tribal Speaker and posted for thirty (30) calendar day, and;

**THEREFORE,** Be It Resolved, the Tribal Council of the Lumbee Tribe of North Carolina votes to approve this "Continuing Resolution", of the FY 2022-2023 Budget with the following provisions:

- 1. Effective October 1, 2023 all expenditures incurred will be attributed to the FY 2023-2024 budget when implemented.
- 2. This Resolution is effective October 1, 2023 thru November 30, 2023.
- 3. All current salaries be frozen
- 4. No new hire employees
