ADMINISTRATIVE COURT APPOINTMENT FOR DISTRICT 3: TRIBAL COUNCIL DISTRICTS 6, 7, 8, AND 20

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, The Tribal Council created an ordinance establishing an "ADMINISTRATIVE COURT"; and,

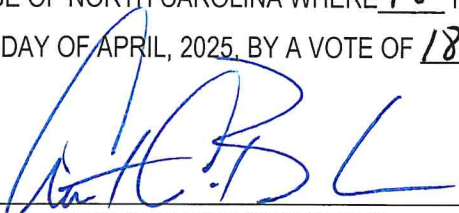
WHEREAS, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Council of the Lumbee Tribe of North Carolina to appoint the nominee; and,

WHEREAS, Samantha Oxendine was nominated for District 3: (Tribal Council Districts 6, 7, 8, and 20); to serve on the Lumbee Tribe of North Carolina Administrative Court; and,

THEREFORE, Be it resolved, The Tribal Council of the Lumbee Tribe of North Carolina does hereby appoint Mrs. Samantha Oxendine to the Administrative Court to represent District 3: Tribal Council Districts 6, 7, 8, and 20. She will serve a five-year term, which will expire on April 17, 2030.

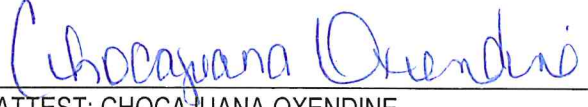
