WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, In accordance with ORDINANCE NO. 2006-000 the Economic Development Committee met with The Spirit Riders for use of the Lumbee Tribe logo on their personal vests, and not for commercial purposes;

WHEREAS, The Economic Development Committee of the Lumbee Tribe of North Carolina at a committee meeting on October 11, 2022, discussed and approved a request made by The Spirit Riders to use the Lumbee Tribal Logo, which will be placed on their personal riding vests only; and,

WHEREAS, The Tribal Council of the Lumbee Tribe of North Carolina (LTNC) supports collaboration between The Spirit Riders and the Lumbee Tribe of North Carolina; and

THEREFORE, Be it resolved the Tribal Council of the LTNC does hereby give permission to The Spirit Riders to use the Lumbee Tribal Logo, which will be placed on the riders personal riding vests and not for commercial purposes.
