## "ADMINISTRATIVE COURT APPOINTMENT FOR REGION 4: TRIBAL COUNCIL DISTRICTS 1, 12, 16, AND 17"

**WHEREAS**, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government; and,

**WHEREAS**, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"); and,

**WHEREAS**, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Chairman & Tribal Council to make nominations and confirm the nominees to the Lumbee Tribe of North Carolina Administrative Court; and,

**WHEREAS**, The Tribal Council created an ordinance defining "ADMINISTRATIVE COURT DISTRICTS."; and,

**WHEREAS**, Ms. Kris McMillian was nominated for Region 4: (Tribal Council Districts: 1, 12, 16, and 17) to serve on the Lumbee Tribe of North Carolina Administrative Court; and,

**THEREFORE**, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the nomination and appointment of Ms. Kris McMillian to the Lumbee Tribe of North Carolina Administrative Court to represent Region 4: (Tribal Council Districts: 1, 12, 16, and 17); and,

**THEREFORE**, Be it further resolved, upon swearing – in Ms. Kris McMillian will serve a 5-year term on the Lumbee Tribe Of North Carolina Administrative Court, which will expire on May 21, 2031.
