WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;



WHEREAS, The Tribal Council of The Lumbee Tribe of North Carolina supports and agrees that Paul Watson has permission to use the Lumbee seal on a poster for a race scheduled for June 16-17, 2023 with the provision that no consumption of any type of alcohol or anything be used by individuals that would extend or display any disgrace or embarrassment to The Lumbee Tribe of North Carolina, and;


