"ELECTION BOARD APPOINTMENT FOR REGION 2: TRIBAL COUNCIL DISTRICTS 4, 5, 9, AND 18"

WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government; and,

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"); and,

WHEREAS, The Constitution of the Lumbee Tribe of North Carolina authorizes the Tribal Chairman & Tribal Council to make nominations and confirm the nominees to the Election Board of the Lumbee Tribe of North Carolina; and,

WHEREAS, The Tribal Council created an ordinance defining "ELECTION BOARD DISTRICTS."; and,

WHEREAS, Mr. Dustin Locklear was nominated for Region 2: (Tribal Council Districts 4, 5, 9, and 18) as board member to serve on the Election Board of the Lumbee Tribe of North Carolina; and,

THEREFORE, Be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina does hereby support the nomination and appointment of Mr. Dustin Locklear to the Tribal Elections Board to represent Region 2: Tribal Council Districts 4, 5, 9, and 18; and,

THEREFORE, Be it further resolved, upon swearing – in Mr. Dustin Locklear will serve a 6-year term on the Lumbee Tribe Of North Carolina Elections Board, which will expire on May 21, 2032.
