WHEREAS, The Lumbee Tribe of North Carolina ("Lumbee Tribe") is a recognized American Indian Tribe of the State of North Carolina, subject to the Constitution of the Lumbee Tribe of North Carolina ("Tribal Constitution") and its inherent powers and self-government, and;

WHEREAS, Article VII, Section 1 of the Tribal Constitution delegates all legislative authority to the Tribal Council of the Lumbee Tribe of North Carolina ("Tribal Council"), and;

WHEREAS, Article VII, Section 5 of the Tribal Constitution mandates that Tribal Council Meetings must be conducted in public session, and;

**THEREFORE**, be it resolved, the Tribal Council of the Lumbee Tribe of North Carolina, in an effort to provide greater transparency and increase member awareness and involvement does hereby approve the recording, archiving and live broadcasts by Tribal Administration of its Tribal Council Meetings, Special Called and Emergency Called Meetings not to include Tribal Council Committee Meetings. Persons attending any meetings of the Tribal Council are not permitted to record or broadcast any Tribal Council Meetings.
